Hardware Overview



PoE In Gigabit 802.3af PoE port. Connect this port to an auto-sensing 802.3af PoE Switch. The switch will automatically activate PoE.

PoE Out Gigabit 24V passive PoE port. Connect this port to a 24V passive PoE device

Installation

1. Connect the Ethernet cable from an 802.3af PoE switch to the *PoE In* port.

2. Connect an Ethernet cable to the *PoE Out* port.



Connect the other end of the Ethernet cable to the PoE device.
