Introduction

Thank you for purchasing the Ubiquiti Networks™ NanoBridge™. This Quick Start Guide is designed to guide you through the installation and show you how to access the airOS™ Configuration Interface. This Quick Start Guide also includes the warranty terms and is for use with the NanoBridge, models NBM3, NBM365, and NBM900.

Package Contents



Products may be different from pictures and are subject to change without notice.

TERMS OF USE: Ubiquiti radio devices must be professionally installed. Shielded Ethernet cable and earth grounding must be used as conditions of product warranty. TOUGH Cable is designed for outdoor installations. It is the customer's responsibility to follow local country regulations, including operation within legal frequency channels, output power, and Dynamic Frequency Selection (DFS) requirements.

Hardware Overview

NBM3/NBM365 Ports



Secondary Port This 10/100 Ethernet port is used for bridging.

Main Port This 10/100 Ethernet port is used to connect the power and should be connected to the LAN and DHCP server.

Reset Button To reset to factory defaults, press and hold the *Reset* button for more than 10 seconds while the NanoBridge is already powered on.

NBM900 Ports



RP-SMA Connector This connector can be used to connect an external antenna.

LAN Port The 10/100 Ethernet port is used to connect the power and should be connected to the LAN and DHCP server.

Reset Button To reset to factory defaults, press and hold the *Reset* button for more than 10 seconds while the NanoBridge is already powered on.

NBM3/NBM365 LEDs



Power The Power LED will light green when the device is connected to a power source.

LAN1

Main The *LAN1* Ethernet LED will light steady green when an active Ethernet connection is made to the *Main Port* and flash when there is activity.

LAN2

Secondary The *LAN2* Ethernet LED will light steady green when an active Ethernet connection is made to the *Secondary Port* and flash when there is activity.



Signal In airOS, you can modify the wireless signal strength threshold values for each LED on the *Advanced* tab under *Signal LED Thresholds*. The default values are shown below:



LED will light red when the wireless signal strength is above -94 dBm.



LED will light amber when the wireless signal strength is above -80 dBm.



LED will light green when the wireless signal strength is above -73 dBm.



LED will light green when the wireless signal strength is above -65 dBm.

NBM900 LEDs



Power The Power LED will light green when the device is connected to a power source.



Ethernet The Ethernet LED will light steady green when an active Ethernet connection is made and flash when there is activity.



Signal In airOS, you can modify the wireless signal strength threshold values for each LED on the *Advanced* tab under *Signal LED Thresholds*. The default values are shown below:



LED will light red when the wireless signal strength is above -94 dBm.

Installation Requirements

- 10 mm wrench
- 13 mm wrench
- Shielded Category 5 (or above) cabling should be used for all wired Ethernet connections and should be grounded through the AC ground of the PoE.

Using the Correct Feed Support Tube

The NanoBridgeM3/M365 and NanoBridgeM900 require different *Feed Support Tubes*, which are not interchangeable. Ensure that you are using the correct *Feed Support Tube* for your NanoBridge model before you begin installation.



NBM3/M365 Feed Support Tube

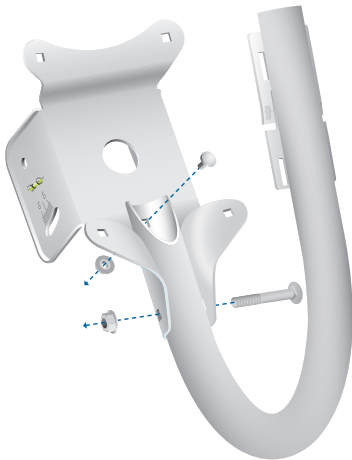


NBM900 Feed Support Tube

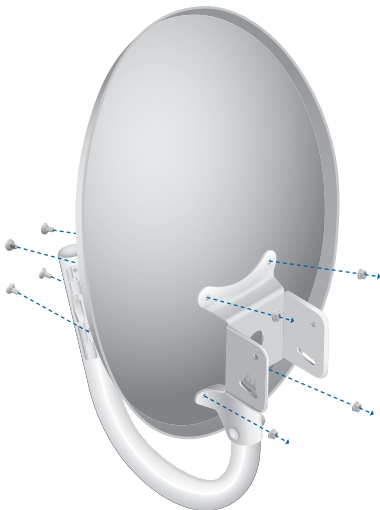
Installation

The installation instructions show the NBM900; however, the same instructions apply to the NBM3 and NBM365.

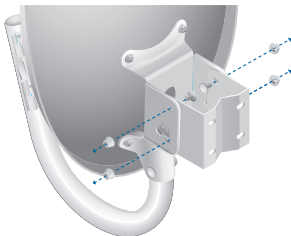
1. Attach the *Feed Support Tube* to the *Dish Bracket* using the *M8x50 Carriage Bolt*, *M8 Serrated Flange Nut*, *M6x15 Carriage Bolt*, and *M6 Serrated Flange Nut*.



2. Attach the *Dish Bracket* to the *Dish Reflector* using the four *M6x12 Carriage Bolts* and four *M6 Flange Nuts*.



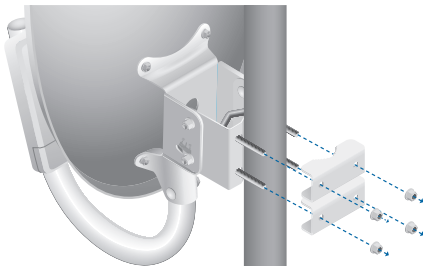
3. Attach the *Mounting Bracket* to the *Dish Bracket* using the four *M8x15 Carriage Bolts* and four *M8 Flange Nuts*.



4. Install the *NanoBridge* by lining up the mounting tabs of the *NanoBridge* with the slots on the *Feed Support Tube*. Then slide the *NanoBridge* into place.



5. Attach the *Dish Assembly* to the pole using the two *U-Bolts*, two *Pole Clamps*, and four *M8 Flange Nuts*.



Note: The mounting assembly can accommodate a $\varnothing$ 1.25" - 2.25" pole.

6. Slide open the cover of the NanoBridge. Connect the Ethernet cable to the Ethernet port of the NanoBridge. Secure the Ethernet cable to the *Feed Support Tube* with the two *Plastic Straps*.



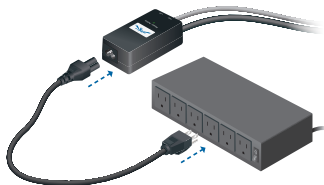
7. Connect the other end of the Ethernet cable from the NanoBridge to the Ethernet port labeled **POE** on the *PoE Adapter*.



8. Connect an Ethernet cable from your LAN or computer to the Ethernet port labeled **LAN** on the *PoE Adapter*.



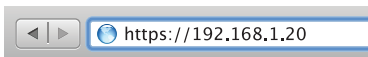
9. Connect the *Power Cord* to the power port on the *PoE Adapter*. Connect the other end of the *Power Cord* to a power strip.



Accessing airOS

Verify connectivity in the airOS Configuration Interface.

1. Make sure that your host machine is connected via Ethernet to the NanoBridge.
2. Configure the Ethernet adapter on your host system with a static IP address on the 192.168.1.x subnet.
3. Launch your web browser and type **https://192.168.1.20** in the address field. Press **enter** (PC) or **return** (Mac).



4. The login screen will appear. Enter **ubnt** in the *Username* and *Password* fields. Select your *Country* and *Language*. You must agree to the *Terms of Use* to use the product. Click **Login**.



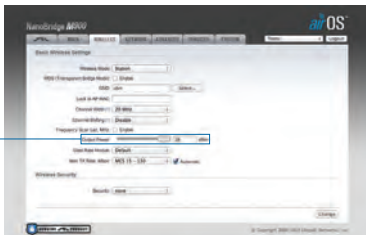
